### **Instructions to applicants**

Candidates who have confirmed their allotment shall take admission at the above notified time and dates in the respective college, failing which the offer of admission will stand cancelled. The candidates will lose all future claims for admission, if they fail to join before the last date notified above.

**At the time of admission, all the relevant certificates/documents in original listed below should be submitted to the institution:**

1. The relevant page of SSLC/equivalent board certificate as proof of age and date of birth
2. Certificate and mark list of qualifying examination (plus two/12<sup>th</sup> std.)
3. Transfer Certificate
4. Course & Conduct Certificate
5. Migration Certificate (if applicable)
6. Certificate of Medical fitness from an authorized Medical Officer with MBBS.
7. A statement to show that the high school in which the student has studies has been accredited by the State/Country/University (if applicable)
8. Equivalence Certificate from Association of Indian Universities (if applicable)
9. Eligibility certificate from Kerala University of Health Sciences (if applicable)

### ***Other Documents***

10. Passport size photographs with white background (5nos. including stamp size photo - 1)
11. Self-attested copies of Photo ID Proof–3nos. (Aadhar)
12. Additionally, two sets of self attested photocopies of all the original certificates (SSLC, Plus Two, T.C. & Conduct Certificate)

### ***NRI Documents***

- a. Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy. Copy of the (Green/ Visa Card /OCI Card /Employment Certificate/Resident Permit) documents of sponsors. The job and validity of the sponsor should be mentioned in any of the above documents. The visa of the sponsor should be valid till the closing date of admission.
- b. Valid Passport copy (front page & back page) with Embassy Attestation.
- c. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.

d. Declaration of the Sponsor should be attested by the Indian Embassy.

(a) In case the sponsor is in other countries, the sworn affidavit shall be attested by the Indian Embassy.

(b) In case the sponsor is already in India, the affidavit shall be notarized by any of the notary public in a stamp paper worth Rs. 200/-i.e. tuition fee and special fee of the candidate for the entire course period will be borne by the Sponsor.

(c) Relationship Certificate (specify the relationship) to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO (MS)No.243/2014/H&FWD dated- 06.08.2014.
