Instructions to the Applicants

ASSISI COLLEGE OF NURSING, ERUMELY

Assisi College of Nursing came into existence in the year 2012. It is a venture of Catholic Diocese of Vijayapuram, Kottayam. Our institution is managed by Assisi Hospital Society. Inspired by our motto, "We Care He Cures", we offer active learning in a vibrant spiritual atmosphere, with well-equipped infrastructure and top-notch faculty. Ragging is strictly prohibited in the college campus.

The Assisi College of Nursing is a Christian minority educational institution established, maintained and administered by the Assisi Hospital Society. The College of Nursing with an annual in-take of 40 students for B.Sc. Nursing was started in 2012. The college is recognized by the Indian Nursing Council (I.N.C.), New Delhi as well as the Kerala Nurses and Midwives Council, Thiruvananthapuram and is affiliated to the Kerala University of Health Sciences (KUHS), Thrissur.

- I. An application for admission to 6 NRI seats of B.Sc. Nursing course for the academic year 2026- 2027, is being invited on the basis of this prospectus.
- II. **ACADEMIC ELIGIBILITY:** To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed the **Plus Two (+2) examination** under the Kerala State Higher Secondary Board (Kerala HSC) OR Central Board of Secondary Education (CBSE) OR Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of Physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).

Note: All applicants must have taken courses in **Biology, Physics and Chemistry** in addition to **English** in the High School Years (during their 10th, 11th and 12th). They should have secured at least **75% marks in Biology, Physics, Chemistry & English at the Plus Two level.**



Only students from high schools accredited by the respective State or the country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and **Equivalency Certificate** to this effect shall be produced.

III. AGE REQUIREMENTS:

Applicants must be at least 17 years of age on before 31st December 2026 (the date of birth being shown on the Matriculation or equivalent certificate).

IV. ELIGIBILITY FOR ADMISSION TO N.R.I. CATEGORY SEATS:

According to the GO(MS)No.243/2014/H&FWD dated 06.08.2014, "An Applicant who depends upon his/her Father/Mother/Brothers and Sisters (inclusive of first cousins) /Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother working abroad" will only be eligible to apply in the NRI category seats.

The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.

V. DOCUMENTS TO PROVE THE NRI STATUS TO BE SUBMITTED AT THE TIME OF ONLINE APPLICATION:

- a. Copy of valid Passport (front page & back page) attested by the Embassy/Consulate.
- b. Copy of Visa/Green Card/OCI Card (Overseas Citizenship of India) attested by the Embassy/Consulate. The visa of the sponsor should be valid till the closing date of admission.

In the absence of the aforesaid documents attested by the Embassy/Consulate, sponsor's passport and Visa/Green Card/OCI Card (Overseas Citizenship of India) attested by NORKA-ROOTS shall be produced, provided the candidate shall furnish a statement from the sponsor in time, explaining the reason for not getting the documents attested by the respective Embassy/Consulate. (G.O(Ms)No.343/2025/H&FWD dated 04/10/2025)

If the sponsor's employment is not stated in the sponsor's passport/Visa/Green Card/OCI card, sponsor's Employment Certificate issued by the employer, attested by the Embassy/Consulate OR if self-employed, a statement in this regard attested by the Embassy/Consulate shall be produced. In the absence of the sponsor's Employment Certificate certified by the Embassy/Consulate, Employment Certificate attested by NORKA-ROOTS shall be produced, provided the candidate shall furnish a statement from the sponsor in time, explaining the reason for not getting the Employment Certificate attested by the respective Embassy/Consulate. (G.O(Ms)No.343/2025/H&FWD dated 04/10/2025)

- c. NRI certificate duly attested by Embassy/Consulate.



- d. Declaration of the Sponsor attested by the Embassy/Consulate.
- In case the sponsor is already in India, the affidavit shall be notarized by any of the notary public in a stamp paper worth Rs.200/-i.e. tuition fee and special fee of the candidate for the entire course period will be borne by the Sponsor. **(Annexure-I)**. The proof of arrival and departure to be provided (copy of respective pages of passport).
 - In case the sponsor is in other countries, the sworn affidavit shall be attested by the Embassy/Consulate. **(Annexure-I)**
- e. Relationship Certificate (specify the relationship) to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO(MS)No.243/2014/ H&FWD dated 06.08.2014.

Note: Relationship should clearly be established. In case relationship is mentioned as Niece/Cousin/Uncle/Aunt only in the space provided for in the certificate, the Village Officer should give the description an explanation of the relation in the certificate itself. Niece/Cousin/Uncle/Aunt should be clarified with specific relationship. The relationship link should be clearly explained. Certificates showing mere Niece/Cousin/ Uncle/Aunt without establishing clear relationship link will be rejected.

VI. REMITTANCE OF FEE

- The candidates selected under the NRI category are **required to remit the prescribed fees for the first year of the course at the time of selection/allotment** itself by way of Online payment/Cheque/DD/RTGS/IMPS only.
- The course fee to be paid at the time of admission to the college will be as per the order passed by the AFRC. Other fees if any, will be charged separately from time to time. Levy of fee on provisional basis is subject to modification depending on the fee regulated by the FRC.

 - b. Recent passport size photograph with white background (to be uploaded)
 - c. SSLC, Plus Two Certificates (copy to be uploaded)
 - d. Self-attested copy of Aadhar Card (copy to be uploaded)
3. Application Fee Rs.1,000/-. You can pay through online payment/RTGS etc. (*for bank details please see the instructions uploaded in the website*) OR take Cheque/DD in favour of Assisi College of Nursing payable at Mukkoottuthara. (Receipt to be uploaded - jpeg – not more than 100 kb)
4. The Cheque/Demand Draft should reach in the office within seven days after the submission of online application (address: The Principal, Assisi



College of Nursing, Propose P.O., Erumely, Kottayam Dist.-686509).

5. **The application form should be completed carefully; furnishing the entire information called for. Late and incomplete applications and applications not in the prescribed format will be summarily rejected.**
6. After submitting the application, the candidate can get a copy of application form in their e-mail address which was written in the application form. They can print the application form and keep with them.
7. The following original documents will have to be submitted at the time of admission.
 - i. The relevant page of SSLC book/ equivalent board certificate as proof of age and date of birth.
 - ii. Certificate and mark list of qualifying examination (plus two/12th std.)
 - iii. Transfer Certificate
 - iv. Course & Conduct Certificate
 - v. Migration Certificate (if applicable)
 - vi. Certificate of Medical Fitness from an authorized Medical Officer with MBBS.
 - vii. A statement to show that the high school in which the student has studied has been accredited by the State/Country/University (if applicable).
 - viii. Equivalence Certificate from Association of Indian Universities (if applicable).
 - ix. Eligibility certificate from Kerala University of Health Sciences (if applicable).

IX. SELECTION OF THE CANDIDATES

- i. Admission to NRI seats in B.Sc. Nursing will be from the rank list prepared on the basis of the percentage of marks obtained in Physics, Chemistry, Biology and English or equivalent subjects in the qualifying examination and performance at the time of interview.



Candidates will be called for interview before the publication of first allotment list in order to verify the certificates & NRI documents.

- ii. **In the case of a tie in the total marks, preference will be given based on the marks obtained for Biology. If there is still a tie, the marks in Chemistry then Physics and then English will be counted. If a tie still exists, the age of the candidate will be taken into account, the elder will be preferred to the younger.**
- iii. The rank list will be published in the college website and will also be intimated through e-mail/phone.
- iv. The management need admit only those students who have complied with the instructions and information furnished in the Assisi College of Nursing Prospectus for NRI seats 2026-2027 admission.
- v. Without prejudice to the directions of the Nursing Councils/Government/ University, the decision of Assisi Hospital Society shall be final on all matters with regard to admission.

X. CANCELLATION OF ADMISSION

Candidates who express their intention not to pursue studies in the Nursing College before the last date fixed for closure of admissions will be eligible for refund of the 1st year tuition fee and other fees except admission fee. They will be eligible to get back their original certificates handed over to the College at the time of admission. In the case of students who leave the College midway, the right of the management for liquidated damages, if any, from such students will be determined by the competent "Civil Court".

XI. PREVENTIVE MEASURES AGAINST RAGGING

1. Every student is required to adhere strictly to the Code of Conduct of the Assisi College of Nursing, Erumely when he/she is admitted.
2. Ragging is strictly prohibited. If it is found during the admission or any time there after that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.



3. Students and parents shall, at the time of admission, furnish an affidavit to the effect that the students will not indulge in any form of ragging (Annexure-II).
4. Every student shall, at the time of admission, furnish a Character Certificate from the institute wherefrom he/she has passed the qualifying examination, which would mention the status of his/her behavioural pattern especially in terms as to whether he/she has displayed persistent violent or aggressive behaviour or any desire to harm others.

In view of thorough academics, round-the-clock study facilitation and mentoring, B.Sc. Nursing degree course in Assisi College of Nursing, Erumely is a residential collegiate education system.
